INVITATION FOR PRE-QUALIFICATION FOR THE IMPORTATION OF FERTILIZER FOR THE PERIOD OF July 2019 to June 2020 (FOR LISTED PRE-QUALIFIED IMPORTERS FOR THE PERIOD OF JULY, 2018 to JUNE, 2019 NO NEED TO APPLY)

- 1.0 Tanzania Fertilizer Regulatory Authority (TFRA) has been established by the Fertilizer Act, Cap 378 and mandated by the Fertilizer (Bulk Procurement) Regulation, GN 49/2017 to coordinate importation of fertilizer through the Bulk Procurement System (BPS). The Fertilizer (Bulk Procurement) Regulations requires the prescribed types of fertilizer to be procured under the Bulk Procurement System (BPS).
- 2.0 The Tanzania Fertilizer Regulatory Authority intends to Pre-qualify fertilizer dealers for importation of fertilizer i.e DAP and UREA in Tanzania under Bulk Procurement System (BPS).
- 3.0 Average annual total volume of DAP and UREA imported is 260,000+/-20% Metric Tons; Tenders shall be floated on product basis whereas the estimated quantity per year is as provided below:-
 - a) DAP 90,000 -110,000 MT

b) UREA 150,000 - 170,000 MT

- 4.0 Both locally registered companies and international companies are allowed to participate in BPS tenders.
- 5.0 Pre-qualification will be conducted under International Competitive Bidding (ICB), through the procedures specified in the Fertilizer (Bulk Procurement) Regulation, 2017 and The Fertilizer Bulk Procurement Guidelines of 2017.
- 6.0 The pre-qualified bidders shall be eligible to participate in tenders for importation and supply of DAP and UREA from 1st July, 2019 to 30th June, 2020.
- 7.0 A complete set of pre-qualification documents in English language can be collected by interested companies at TFRA offices after applying and receiving an invoice to make online payment to TFRA account of a non-refundable fee of five hundred United States Dollar only (**USD 500**).

Bring the deposit slip to TFRA office from Monday to Friday (Working Days) between 0800 hrs and 1530 hrs.

- 8.0 Application for pre-qualification should be submitted in sealed envelope, delivered to the address below, before or on Tuesday 23rd April, 2019, at 1100 hrs and be clearly marked "**Application to be Pre-qualified for the Importation of Bulk Fertilizer. Pre-qualification no. TFRA/PQ/2019-20/F/01**".
- 9.0 Applications sent by email will not be accepted.
- 10.0 Applications submitted beyond the specified time shall not be accepted;
- 11.0 Applications will be evaluated and results be announced by 30th May, 2019 for pre-qualified importers to participate in the tenders from 1st July, 2019 to 30th June, 2020;
